IMPORTANT Without your e-mailed and original signed documents, your child will be unable to attend, even to observe.

HEALTH & SAFETY PROTOCOLS (subject to change):

- Please read through <u>ALL</u> of our "Health & Safety protocols" on our website at <u>www.pulsedanceworks.com</u> Health & Safety tab, BEFORE you visit our facility. Ensure to refresh and clear cache and cookies each time you visit our website to ensure you are viewing the most up to date information.
- 1 Parent per child/dancer under the age of 8years, must wait in the lobby for the full duration of your child's complimentary class in case your child, or the instructor, needs you for any reason.
- No food or drink is allowed except water in a closed and leak free bottle.

WHAT TO WEAR:

- Comfortable clothes that you can easily move in (fitted t-shirt or tank top with leggings or track pants)
- Bare feet or proper dance shoes (NO dancing in socks or outdoor shoes allowed due to safety reasons)
- Hair is to be tied back in a secure pony tail

REGISTRATION:

- Registration is ongoing all year round. The dance season runs from Sept-May with a yearend dance recital "Showcase" followed by weekly evening summer classes and summer camp. We also offer Private classes and dance class 8, 10 or 12 week sessions that run parallel to our seasonal weekly classes (no recital performance).
